# ---- AFGE NBPC Local 2544 - Election of Officers ---

**Eligibility to Vote:** Members must have their dues paid through Nov. 2020. Members whose dues are deducted through a check-off arrangement with their employer may not be disqualified from voting because of any delay or failure by the employer to send the dues to the Union. Members will be required to show an ID and sign for their ballot. Members may only vote once. Duplicate voting will null and void those ballots and not counted.

**Election & How to Vote:** The election of officers will be conducted by secret manual ballot at each station. Voting instructions will be posted at the polling locations. Write-in votes are not permitted and will not be counted.

## **Absentee Ballots**

Absentee ballots must be requested directly from Election Committee Supervisor Harley Hembd, 623-693-3225. Absentee ballots may be requested by telephone, FAX: 602-281-6188, or by email at [harley.hembd@afge.org](mailto:harley.hembd@afge.org). Members must verify their identity and provide their full name, address, and phone number to receive a ballot. Absentee ballots should be requested as soon as possible to provide the member the best opportunity to receive and return the ballot in time to be counted on **Nov 19, 2020**. Absentee ballot voting instructions will advise a member to mark his/her ballot in private, seal it in the secret ballot envelope, and place the secret ballot envelope into the stamped self-addressed return ballot envelope to US Post Office, Tucson, AZ, 85752. Printing his/her name and address on it and then mail. Please follow the instructions carefully.
